Art. 2 Admission requirements

To be eligible for the programme, students must hold a degree in any of the following classes pursuant to Ministerial Decree 270/2004: LMG/01 Law; LM-52 International Relations; LM-90 European Studies. Applicants holding an equivalent qualification obtained in Italy or abroad may also apply for admission.

Art. 2.1 Simultaneous enrolment in two study programmes

Simultaneous enrolment in this vocational master and another study programme offered by this or another University is allowed within the limitations set forth in Ministerial Decree no. 930 of 29 July 2022.

For more information on the possible combinations of study programmes, and **how to apply** for simultaneous enrolment, see [Simultaneous enrolment in two higher education programmes | University of Milan \(unimi.it\)](#).

For some combinations, simultaneous enrolment needs to be authorised by the managing bodies of the two study programmes in question.

Off-track students may not enrol in a second study programme.

Art. 2.2 Upcoming graduates

Upcoming graduates in the degree classes indicated in this article may also apply for admission, as long as they obtain their degree within 30 days from the start date of the programme. In such case, applicants will be admitted "conditionally", and will be required to provide a self-certification of having earned the degree, via the [InformaStudenti platform](#) (category Postgraduate > Vocational masters). Failure to comply will result in exclusion from the programme.

Art. 3 Application for admission

Applications for admission must be submitted by 23:59 on 6 October 2025, as follows:

- 1) Register on the University portal at <https://registrazione.unimi.it>. This step is not required of those already registered on the portal or in possession of University login credentials (final year students of the University of Milan or those who graduated from this University less than a year ago), or a SPID identity;
- 2) Log in with your credentials and submit an application for admission to the programme using the online procedure available at



<http://studente.unimi.it/ammissioni/a/master/checkLogin.asp>;

- 3) Pay a non-refundable €50.00 application fee (Regulations on Tuition and Fees, Waivers and Scholarships);
- 4) Upload the following documents in .pdf, .jpg or .rtf format:
 - CV written in English and specifying the degree held;
 - motivation letter in English.

Applicants with a foreign qualification should refer to art. 6 of this call for applications.

Applicants who provide false data or fail to meet the requirements will be excluded from the programme.

Applications of those who do not pay the application fee indicated in point 3 will be disregarded.

Art. 4 Applicants with SLD

In order to ensure equal treatment of applicants, those holding a Specific Learning Disorders (SLD) certificate issued by the National Health Service, a private affiliated centre, or a private specialist (with a compliance certificate from the competent health authority) pursuant to Law 170/2010, are required to **email their certificate to COSP SLD Services (ausili.ammissioni@unimi.it) at least 15 days before the interview.**

If the SLD was diagnosed in childhood, and the certificate is over three years old, students should apply for an updated certificate, to be submitted after enrolment for the purposes of using SLD accommodations as offered by the University.

Art. 5 Applicants with disabilities

In order to ensure equal treatment of applicants, those holding a certificate of disability (*invalidità civile*) and/or handicap pursuant to Law 104/1992 **may apply for accommodations by writing to COSP Disability Services (ausili.ammissioni@unimi.it) at least 15 days before the exam, attaching the certificate issued by the competent public health office.**

Applicants holding outdated certificates are required to apply for an updated certificate, to be submitted after enrolment for the purposes of using disability accommodations as offered by the University.



Art. 6 Applicants with foreign entry qualifications and student visa

Until then, applicants are admitted to the programme conditionally, and may be excluded from the programme at any time if they are found not to meet the requirements.</p>

Art. 7 Selection procedure and ranking criteria

Admission to the programme is based on an interview aiming to ascertain applicants' knowledge and motivations, as well as on an assessment of the CV and motivation letter uploaded by each applicant when applying online. The CV and motivation letter must be written in English.

Assessment criteria:

- interview: up to 50 points;
- CV and motivation letter: up to 50 points.

The minimum score required for admission is 60/100.

Interviews will be held on **14 October 2025 at 15:00 at the Department of Italian and Supranational Public Law**. In order to encourage participation of foreign and non-resident applicants, interviews may also be held online on Microsoft Teams. In this case, applicants must send an email to the Student Office of the vocational master (glam@unimi.it), in order to receive the link for the interview at the email address they specified during the application process.

Art. 8 Ranking list, enrolment and payment

Ranking list and enrolment

During the online enrolment process, **foreign students** are required to upload a copy of their Italian tax ID (*codice fiscale*); non-EU citizens must also upload a copy of their residence permit.

Those who do not wish to enrol are required to promptly notify the Student Office for Phd, Vocational Masters and Post-Graduate Programmes via the [InformaStudenti online platform](#), selecting the category Postgraduate > Vocational masters.

8.2 Payment

Payment of the first fee instalment is necessary to finalise enrolment. The first instalment, which amounts to **€1,516.00**, must be paid after the enrolment procedure and by the deadline specified in art. 1.

The enrolment service automatically redirects to the PagoPA platform, where applicants can choose their preferred payment method (e.g. credit card, bank transfer or cash payment at a licensed establishment).

For vocational masters, the enrolment fee is divided into two instalments, which fall under a **single payment obligation**. Therefore, the payment of the first instalment gives rise to the obligation to pay the second instalment as well. The second instalment is also due by students who drop out or formally withdraw from the programme.

As the vocational master is part of the University's institutional activities, no VAT is applied to the enrolment fee, and no invoice will be issued.

8.3 Enrolment fee waiver for applicants with disabilities

Students with a disability at or above 66% and/or a recognised handicap (art. 3, paragraphs 1 and 3 of Law no. 104 of 5 February 1992) are only required to pay the stamp duty in the amount of €16.00. Payment is to be made **online** after completing the enrolment procedure.

Art. 9 University credentials

Art. 10 Scholarships

Should this call for applications provide for the allocation of full or partial scholarships, these will be indicated in the attached programme specification, or on the vocational master's webpage on the University website (<https://www.unimi.it/en/education/postgraduate-and-continuing-education-programmes/vocational-masters-programmes-and-advanced-courses/vocational-masters-programmes-list>). Students in receipt of a scholarship are still required by law to pay the €16.00 stamp duty.

Art. 11 Payment of the second instalment

The second instalment must be paid by the deadline set forth in art. 1, via the [online payment service](#); students can access this service from [UNIMIA](#), i.e. the student personal portal, using their own University login credentials.

The service redirects automatically to the PagoPA platform, where students can choose their preferred payment method (e.g. credit card, bank transfer or cash payment at a licensed establishment).

Late payment of the second instalment will be subject to a penalty fee amounting to €30.00, if payment is made within the first 15 days after the deadline, or to €60.00, for payments made thereafter.

Art. 12 Attendance

Course attendance is mandatory and verified according to course-specific procedures.

Only those who have attended at least two thirds of the planned training activities and completed the satisfaction survey may take the final exam.

Studies cannot be interrupted for any reason whatsoever.

Students are subject to the applicable provisions of the Regulations on Tuition and Fees of the current academic year regarding payment settlement, withdrawal, refunds and tuition waivers for students with a disability over 66%.

Art. 13 Withdrawal

Enrolled students who intend to withdraw from the programme must fill the [form available on the website](#) and send it to the Student Office for PhD, Vocational Masters and Post-Graduate

If withdrawal occurs prior to the actual start of the programme, any fees paid will be reimbursed, minus 10% of the enrolment fee, which will be withheld by the University to cover general and administrative costs.

Therefore, the payment of the first instalment gives rise to the obligation to pay the second instalment as well. The second instalment is also due by students who drop out or formally withdraw from the programme.

2nd level vocational master programme in Global Litigation and Arbitration Management (GLAM)

Learning objectives

In the new millennium's globalised economy, disputes increasingly take on a cross-border dimension. They may therefore involve a number of different legal systems and may be resolved in different forums that are subject to differing regulations and procedures. This creates particular issues which, if they are to be resolved, will require the deployment of a whole host of professionals with specialist knowledge in various roles tied to preventing and managing cross-border disputes. These include attorneys, general counsel, managers, public officials and academics with a scientific interest in cross-border disputes. The vocational master programme aims to provide participants with this knowledge from a holistic and entrepreneurial perspective. On the one hand, students get to grips with the various tools that can be put to use for preventing and resolving cross-border disputes, and techniques that can be leveraged to rationally select the tool that is best suited to the case in question. On the other hand, students examine how these tools are coordinated and chosen. The overall intention is to bring about more efficient case management in terms of weighing up costs and benefits and monitoring business risks. At the same time, the vocational master programme aims to provide learners with specific competences in litigation and arbitration for dealing with cross-border disputes. This novel approach is intended to meet the need increasingly being felt by businesses to manage disputes as "projects" with a view to maximising profits, and by legal advisers to provide genuine "added value" with their services. The programme is delivered entirely in English.

Employment prospects

The legal competences in demand in the new millennium are not only required for exercising the traditional professions (lawyers, notaries and judges), but are also demanded for other roles. Graduates of the vocational master programme can find employment as: lawyers, general counsel, paralegals, forensic consultants, project managers and public officials with international organisations and not-for-profit institutions.

Places available

Places are capped at 30 students. The University reserves the right not to run the programme if



the number of enrolled students is less than 15.

Course organisation

The vocational master will run **from 19 January 2026 to 30 September 2026**. Courses will be partly online and partly in person at the Department of Italian and Supranational Public Law of the University of Milan.

The programme includes 395 hours of face-to-face teaching (corresponding to 42 university credits, or CFUs), 102 hours (7 CFUs) of other forms of training and 18 hours of e-learning (1 CFU).

Teaching is structured as follows:

Introductory courses:

- Basics of Private International Law
- Basics of Public International Law
- Basics of Comparative Civil Procedure Law
- Basics of European Union Law
- Basics of Comparative Private Law

Core courses:

- International Commercial Arbitration
- International Investment Arbitration
- International Commercial Litigation
- International Enforcement of Judgments and Arbitral Awards
- Litigating Before International Courts (ECtHR, ICJ, CJEU)
- Economics of Dispute Settlement

12 short courses/seminars to be chosen from the following:

- Accounting and Regulatory Management of Claims
- Antitrust-Related Disputes
- Arbitrating Under Institutional Rules (CAM, ICC, LCIA, PCA)
- Artificial Intelligence and Disputes Resolution
- Business, ESG/Human Rights and Corporate Social Responsibility
- Corruption and Cross-Border Disputes
- Cross-Border Insolvencies
- Damages Quantification
- Disputes on Cultural Goods



- Interim Measures
- IT/IP Cross-Border Litigation
- Managing Delay and Cost Claims in Construction Projects
- Post M&A and Shareholders Disputes
- Price Adjustment Disputes
- Sanctions and Commercial Disputes
- Securities Litigation and Financial Markets
- Sport Arbitration
- Techniques for Settlement Negotiations
- The Dispute Settlement System of the WTO
- The Vienna Convention on the International Sale of Goods.

To complete the programme, students must take a 250-hour internship (10 CFUs) and a final examination consisting of a written and oral exam testing the skills acquired during studies.

During the programme, students will be assessed on topics covered during classes by way of written tests with multiple-choice and open-ended questions, practical cases to be solved and oral tests. Students are not awarded marks for these tests and the final exam, but only a "pass" or "fail"; in the case of a "fail" outcome, the exam must be repeated.

A total of **60 CFUs** are awarded for the vocational master.

Enrolment fee

Admitted applicants must pay an enrolment fee amounting to €12,016.00 (including insurance coverage and stamp duty).

The enrolment fee must be paid in two instalments:

- first instalment, amounting to €1,516.00, by the enrolment deadline;
- second instalment, amounting to €10,500.00, by the deadline specified in art. 1.

The first instalment is inclusive of the stamp duty.

For vocational masters, the enrolment fee is divided into two instalments, which fall under a **single payment obligation**. Therefore, the payment of the first instalment gives rise to the obligation to pay the second instalment as well.

The University of Milan participates in the **PA 110 e lode** initiative, launched by the Department

for Public Administration to strengthen the skills of public employees. Public employees enrolled in a PA 110 e lode programme will benefit from a €330.00 reduction on the second instalment of the tuition fees. Moreover, a refund of 50% of the tuition fees will be granted to those who complete the programme. In any case, the maximum amount of refund is €2,500.00.
